<p><i>What investment services and advice can you provide me?</i></p>	<p>We offer discretionary investment advisory services and financial planning services to retail investors. As part of our service we consult with you on a wide array of wealth management issues, including income and estate taxes, estate and financial planning, and retirement planning. We act as fiduciaries in our relationship with you, which means we are ethically and legally bound to act in your best interest. We monitor your accounts on a continuous basis. As discretionary managers, we instruct your custodian to execute trades in your account without communicating with you about each trade. Our minimum relationship size for investment advisory services is \$500,000. Exceptions to this minimum are occasionally made. <p><i>What are your legal obligations to me when acting as my investment adviser?</i></p> <p><i>How else does your firm make money and what conflicts of interest do you have?</i></p>	<p>When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here is an example to help you understand what this means: Since the majority of our fees are based on the amounts of assets we manage for you, if we advise you to use some of your investment assets to pay off a debt, like the mortgage on your house, that would reduce our revenues. But we are legally and morally obligated to advise you to do what is right for you regardless of the effect on our revenues. <p><i>How do your financial professionals make money?</i></p>	<p>Our firm operates as a partnership. Our owners share in the profits we make based on a formula that uses a method that considers our revenues and profits. Our only source of revenues is fees from clients like you.</p>
